CARAMEL LOLLIPOPS

We provide production services in the scope of lollipops - dietary supplements in flat and spherical form, foodstuffs and medical devices. We rely on our own or commissioned formulas. We are also ready to recreate existing products, giving them the same parameters or modernising them with new solutions. Taking special care of the smallest consumer of lollipops, i.e. children, each lollipop has a stick with a hook to prevent the stick from loosening from the lollipop. It is a safety element that protects the child against accidental swallowing of the lollipop head. The foil in direct contact with the lollipop does not contain any colouring dye usually used by manufacturers. The colour is used on wraps and flow packs only from the outside. All packaging materials used for lollipops are approved for contact with food.





The process of making soft capsules is a complex process involving the production of a gelatin mass that will form the capsule shell and the filling. The two ingredients are then combined in an encapsulation process. The produced capsules are dried, polished, sorted and then sent for packaging. Production takes place on a modern, fully automatic production line from a reputable supplier. The line is equipped with a control of the capsule filling process, gelatin thickness on the capsule and automatic capsule drying.
