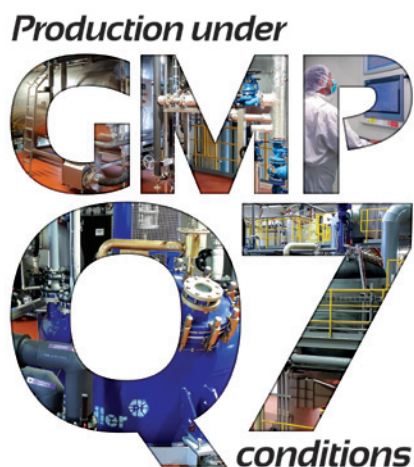

To attain our high-quality levels and maintain the trust given to us by our customers, suppliers and regulators, we have our own on-site laboratories that include research and development facilities to test and continuously improve all aspects of our production.

At Macco, there is high attention placed on the prevention of any contamination occurring during all production stages. Our highly trained Maccovians pack all products in our on-site **GMP Q7 certified** facility equipped with **Clean Rooms to ISO 8 / Class D for APIs** and in **FSSC 22 000** rooms for food industry.

Macco also delivers solutions for customer specific needs and offers the following production activities: **blending, grinding, milling, sieving and repacking**. Our standard pack sizes are low volume sacks and jars from 50 grams, plastic drums from 12kg to 250 lb, bags from 10kg to 25kg, fibre drums from 25kg to 250 lb, 25kg cardboard boxes, big-bags from 400kg to 1,000kg.

Drawing on our vast experience selling mineral salts from our own production and our knowledge of both the legislative and market requirements for quality and service of such products, Macco also offers high-end quality mineral salts from third party, reliable and qualified producers. The result of this extended service is that Macco are able to offer our clients as full a package of materials necessary for their production.
